#### Order of the Gathering . . .

Ralph commented that we are not a bank . . . in hopes of invigorating participation in our upcoming Walks that the Board would pay \$100.00 for each Team Member and Pilgrim. Reducing the expense of the 3 day weekend making it more "affordable". The maximum of \$10,000.00 per walk in 2024.

#### **Comments:**

Larry Bader asked for financial information over the last 3 years

- Did we end these walks on a positive or negative balance?
- Did we know a minimum reserve balance we need to maintain to cover future budgets?
- Renewal materials need to be replaced from the last walk do we know the cost of those items?
- Tuesday Nights are possibly one reason we don't have the attendance at the Gatherings we would like to have could we consider planning a Saturday Gathering giving families the ability to join us maybe even a Potluck / Picnic style ?

Chris Hornburg mentioned that we have approximately \$3,600.00 set aside in dedicated accounts for Scholarship for Team Members as well as Pilgrims.

Final decisions were tabled until we could obtain more information – Ralph wishes to continue discussion going forward concerning being good stewards of our funds.

### Question was raised as to the Walk # progression

Women's Walk #64 – has been cancelled – not postponed – we want to honor what was. Men's Walk #65 – 2024 lead by John Decker Women's Walk #66 will be hosted next September, 2024.
